Documents at Burton Agnes.

THE following selections are made from the muniments preserved in some old chests in the large room on the top floor of Burton Agnes Hall. Some short time ago Mr. Wickham Boynton very kindly allowed me to look through the contents of the chests, and I found old court rolls, deeds, accounts, etc., from the thirteenth century to comparatively recent times. Most of the earlier documents are in Latin, but a few are in old French. Through the kindness and generous help of my friend, Mr. William Brown, F.S.A., I am able to give the contents of some of the older deeds. These deeds were very interesting to me, and I venture to think they may be of interest to the members of our Society. are full of miscellaneous items of local information. I wish to express my thanks to Mr. Wickham Boynton for permission to print the documents, and to Mr. W. Brown for his help with the translations and useful suggestions.

Acaster Malbys.

1.-Easter Term 22 Edw. III. (1348).

A fine between William Malbys Kt. plaintiff and Master Thomas Sampson. William Sampson, John de Sutton, parson of Acastre and William de Harum, parson of Halniby, deforcients, of the manors of Acastre Malbys, Coupmanthorp, Skalton, Muston, Fyvelaye* and Aton in Clivelande and ten pounds rent in South Oteryngton. The manors, etc., with the homages and services of Roger de Burton and Isabelle his wife which they held of the plaintiffs were settled upon William Malbys for life, remainder to Thomas, son of the said William Malbys in tail male; remainder to John, Thomas's brother in tail male; remainder to Richard, John's brother in tail male; remainder to Walter, Richard's brother in tail male; remainder to right heirs of Richard Malbys.

2.-Eve of the Purification, 42 Edw. III. (1 Feb. 1367-8).

Release from John de Langeton, citizen of York, to William Fairfax of all right in the manors of Acastre Malbys, Coupmanthorpe, Muston, Fyveley,* Scalton, and Halneby which William had of the grant of Walter Malbys Kt., and all the lands, etc., which William had of the said Walter in the vills of Little Ayton in Cleyveland and Sutton under Whytstanclyff, with the advowson of the Abbey of Newbrough and the churches of Halneby, Scalton and Ottryngton. Witnesses—Brian de Stapilton, John Chaumount, William de Nessefeld, Kts.; Richard de Aske, Thomas Colvile, William Dayvill.—York.

3.-Friday after Trinity (20 June) 1337.

Power of Attorney of Walter de Bovyngton, Lord of Acclum, to William de Bovyngton to deliver to Sir John Neuham, chaplain, seizin of William Senhall, Walter Gilmyn, Beatrix widow of Walter Palmer, William Hemeryng, Will. son of Will. Hendyngs', and Rob. son of Rob. with their sequels and chattels and of 10 crofts with tofts and 10 bovates of land in Acclum, which his said natives held in the said vill according to the tenor of the charter in the possession of the grantor.—Acclum.

4.—Friday after S. John Bev., 39 Ed. III. (9 May 1365).

Agreement between Thomas de Boynton and Symon Rous of Aresom, whereby Thomas grants to Symon his table (tabeyl) for the time of his life and a chamber in the manor of Acclum as long as he cares to have it, and if Symon does not agree then he is to have every 13 weeks, 2 bushels of corn and a house in the said vill of Acclum.—Acclum.

5.—Thursday after the Purif., 4 Ric. II. (7 Feb. 1380-81).

Release from John de Grenehowe, rector of Kyldale, to John de Brompton, parish chaplain of Aklom, of all right in all the lands, etc., in Yorkshire which John and he had had of the grant of Thomas de Boynton, Kt. Witnesses—John de Percy of Kydale, James de Towcotes, John de Hilton, Robert de Thormondby, John Waxand.—Aklom

Seal- A virgin and child.

6.—Tuesday before the Inv. of H. Cross (27 April) 1333.

Grant by Acrisius² son and heir of Halnath de Halnahtby to John de Clif living in Aldebury by Manfeld on Tese and Teffania,³ his wife of all the lands, etc., which John de Clif held there of the donor's inheritance. Witnesses—Sir Thomas de Laton, Geoffrey de Melsanby, Robert Greteheued of Staynways, John Greteheued of Caldewell, Ivo de Carleton.—Aldebury.

Seal (heraldic)—broken. A shield charged with a fess and in chief three fleur de lis in base, . . . *Only one letter is legible of the legend, namely A.

7.—Friday in Easter Week. 19 Ric. II. (7 Apr. 1396).

Release from Joan, Widow of Helnath de Helnaby, Kt. to Thomas de Cleseby ⁵ and Richard Forbour, chaplain, of her dower in the lands of Thorpe, Aldburgh, Carlton, and Jolby for term of the lives of Thomas and Robert her sons.

Barmston.

8.-c. 1200.

Grant by Walter Burdun of Wincketon 6 to the Hospital of St. Mary of Bridlington for the use of the poor, of 4 acres of land in Wincketon lying near the spring (fons) of Schatphou 7 in his culture towards the north, on the west part of the vill of Wincketon, and an acre and a perch at Arneshou 8 in his culture towards the south, and 3 perches in Crifting within and outside the ditch on the east side of the vill of Wincketon. Witnesses—Master Robert de Bridlington, Robert de Redenesse, Andrew Marescallus, Lucus Silver, 9 Robert, then the

Bond in 100 shillings from Roger Randolf of Killum to Sir John de Mounceux Kt. payable at Berneston on the assumption of B. V.—Berneston.

11.—Friday after the feast of St. Valentine Bp. 5 Ric. II. (1381-2).

Grant by Joan, widow of John de Mounceux of Berneston and for the term of her life to Robert de Fangfos, parson of the church of Berneston, Roger de Mounceux, Alexander de Mounceux and Stephen de Nigthgal of all her property in Ulram. Witnesses—John Bourge, John de Berneston, John de Ulram, William de Burton de Ulram, William son of Amand de Berneston and John Cocks of the same.

12.—All Saints' Day. 9 Ric. II. (1 Nov. 1385).

Grant by John Mounceux son and heir of John Mounceux of Berneston to Robert Manfeld, Clerk, and John Alnewyk, Chaplain, of the Manor of Berneston, after the death of Joan his mother who had it for the term of her life.—Berneston,

13.—24 Nov. 16 Ric. II. (1392).

Writ from the King to the Sheriff of Yorkshire to cause Joan widow of John Mounceux of Berneston to appear at Westminster on the octave of St. John Bapt. to satisfy Guy Cock of Bridlington about a debt of 20 marks and of six shillings and eight pence costs.

14.-20 Oct. 1404.

General Power of Attorney from William Mounceux of Berneston in Holdernesse, clerk, to Alexander Mounceux, Sir Thomas Semer, Sir Thomas de Berneston and Sir John Mounceux, clerks. Sealed by the Dean of Holdernesse.— Berneston.

15.—31 Dec. 13 Hy. IV. (1411)

Grant by William Windelow and Beatrix his wife to Alexander Mounceaux of a messuage and two boyates of land in Wyakton, Witnesses—John de Ask, Thomas Seintquintin, William Twyer, Richard Bonvge (?), Thomas Burdon.—Wyakton.

16.—8 Jan. 13 Hy, IV. (1411-12).

Release of the same property from Robert Windelow son of William Windelow of Wynkton to Alexander Mounceaux.—Wynkton. Witnesses (as above).

17.—Annunciation (25 Mar.) 1429.

Grant by Alexander Monceux of Bridelyngton, Esq., to John Constable, Lord of Halsham, Esq., William Twyer, of Gaunstead Esq., William Mounceaux his brother Chaplain, and Thomas Smyth of Bridelyngton, of the same property.—Wynkton. Witnesses—William de Brigham, Sir John Wade, rector of Barneston, Thomas Dand of Wynkton, John Wiske of the same.

18.-28 Jan., 1450-1.

Release from Thomas Smyth of Beverley, chaplain to William Twyer of Gaunsted Esq. of the same property.11

19.—10 Aug., 7 Hy. VI. (1429).

Grant from Maud, widow of John Mounceux, of Bernston, Esq., to John Wade, parson of Berneston, Thomas Sprotelay, charlain of Beverley, John Benyngton of Hedon, of her manor of Fernston. Grant in special tail by Gerrard of St. John, living in Berneston, to Adam, the servant of Master Thomas de Barneby, Rector of Berneston, and to Agnes his wife of all the land he had had of the grant of Sir William de Fortibus, Earl of Albemarle, whose Chamberlayn he had formerly been in Berneston, with capital messuage, etc., except 2 bovates which he had granted to Lady Hawyse de Munceus, saving to his other daughters, who should survive him, their portion of their inheritance. Covenant by Adam and Agnes to maintain in food and drink Gerrard and his daughters during the term of his life so long as they behave themselves; and to

John de Mounceux, by John de Beverle his Attorney seeks against Robert, the Abbot of Thorneton, a messuage and 4 acres of land in Wynketon,15 which the Abbot holds of him by certain services and which ought to revert to the said John according to the form of a "shetule" provided in that behalf by the Common Council of the King of England inasmuch as the said Abbot has ceased for 2 years to do the said services, and whereof he says, that the Abbot holds the said tenements of him by homage, fealty and scutage of the Lord King of 40s., when it chances to be 10s., and when more more and when less less, and by the service of a pound of pepper, of which services, John was seized by the hands of the said Abbot, as by the hands of the real tenant, etc., namely, of homage and fealty as a fee in right, and of the other services in his demesne as a fee and right in the time of peace, and the time of the now king, up to two years before the issuing of this writ viz. He granted the following annuities to Nicholas Holborn, 26s 8d, on property in Salcoke by a deed dated 22 Feb., 9 Hy. VIII. He also died seized of property in Snayton and Boynton after the death of Cecily Boynton, widow, and also of reversion of property in Langtofte, Foxholles, and Bothorppe, after the death of William Pinder, chaplain by the grant of Thomas Boynton deceased, which grant was shown at York Castle before Thomas Suttyle, Esq., escheator on the death of the said Thomas Boynton, Esq., and also of the reversion of two closes of pasture in Seyton in Holderness on the death of Robert Skelton of the grant of Lady Margaret Boynton vowess (votissa) widow of Henry Boynton deceased, which grant was shown at York Castle before Ralph Pullan, Esq., escheator on the death of the said Margaret. The said Margaret being seized of two and a half bovates of land in Seton gave an annuity of 20s. to Martin Johnson, alias Hill by a deed dated 26 Feb., 21 Hy. VIII. He was also seized of the reversion of the manor of Rouxby on the death of Cecily Boynton widow, which she had by a deed dated 12 Feb. 31, Hy. VIII., and also of the reversion of a close of pasture in Barnston called Thornclose on the death of John Brygham who held it by the grant of the said Matthew by a deed dated 4 Aug. 28 Hy. VIII. In Burton Agnes are 12 carucates of land held of Brus and Brus of the King where 21 carucates and 2 bovates make a knight's fee. In Thirnun are 7 carucates and 2 bovates of which 6 carucates and 10 bovates are held of Marlay and Marlay of Brus and Brus of the King where 21 carucates make a knight's fee. In Grauncemore are 4 carucates and a half, 4 of which are held of Herbert de St. Quintin and he of Marlay and Marlay of Brus and Brus of the King where 21 carucates make a knight's fee.

In Burton Agnes there are four score and sixteen bovates of land and they make 12 carucates, in Harpham, there are five score and six bovates and they make 13 carucates and 2 bovates, of which these are in the lord's demesne and his bondage, 63 bovates, of which 52 bovates are held directly by foreign service of Herbert St. Quintin and he of Marlay, and 11 bovates are held directly by fee farm of Colvile and he of Marlay by forensic service.

And William de Harpham holds 20 bovates, Richard Astin 2 bovates, Thomas, son of Thomas, 2 bovates by forensic service directly of the lord of Harpham, and the same Thomas holds four bovates, 2 of which are held of the lord of Harpham by forensic service directly, and he of Colvile by fee farm and Colvile of Marlay by forensic service, and other 2 bovates are held directly by fee farm of Claervaux and he of Marlay by forensic service. William St. Quintin holds in his bondage 13 bovates and a third part of a bovate which William at the gate held, Ancelm Dreng holds 4 bovates, John Hernyng 2 bovates, Roger Francys a third part of 2 bovates lying in the moor. Richard the hawker the third part of 2 bovates. All these held directly of Herbert St. Quintin by foreign service and he of Marlay. William St. Quintin holds in his bondage 12 bovates, Ancelm Dreng I bovate, Deues neue (?) half a bovate, Roger Frauncys a third part of 2 bovates lying in the moor, Richard the third part of 2 bovates, John Oustiby 2 bovates, all these bovates held of Colvile and he of Marlay by forensic service. And when the scutage is at 40s. then ought each of the above named freemen who hold

by foreign service to give to his lord directly as is said above

in the roll, because 10 carucates make a fee.

Also William Sentquyntyn by his dede endentyd A.D. 1285 confessid the lord of Agnes Burton to be his chief lord for londis in Harpham ut patet portea in hac verba.—A.D. 1285, April 9. It was agreed between William de St. Quintin and Nicholas Clarvaux that William gave Nicholas a toft that Clathewhayte held in Harpham in length 200 feet and in breadth on the north side 24 feet and the south side 28 feet in exchange for a toft held by Alexander, son of Thomas Astin of the same length and breadth, etc.

Roger Stutevill had issue Ancelm who died o.s.p. and 5 daughters Alice, Agnes, Isabell, Gundreda, and one who was a nun, and after Ancelm's death the property was divided among the 4 sisters, Alice, wife of Roger de Marlay, from whom came Roger; and from Roger, Roger; and from Roger, Mary the wife of William de Crastok, and Isabell Somervell, mother to Sir Roger and Philip who now is. From Mary (Crastok), John, died without issue (not true).

Agnes the next sister married Herbert St. Quintin, from Herbert and Agnes came Herbert, John, Ancelm, William, and Alexander, which Agnes after the death of her husband gave by her deed to Alexander her younger son the manor of Harpham, Alexander married Margery de Blaunkmostre from whom came William, from William, Gefferay, from Gefferay, William who now is.

Isabel married Sir Roger Colvile, who had issue Roger; from Roger, Roger; from Roger, Edmond; from Edmond, Robert who now is, who of his perpetuity enfeoffed Sir

William de Sentquyntyn, son of Geffaray.

Gundred married Sir John de Basingham, who had issue John; from John, Rohays, wife to Robert Tattirsall; and

Agnes de Basingham died without issue.
